To Whom It May Concern,

The stability testing of sanitising and soap products consists of tests of the attributes of a product that are susceptible to change during storage and are likely to influence quality, safety and/or efficacy. The frequency of the testing of the subject attributes should be sufficient to establish the stability profile of the product.

Based on a review of stability data, relative to the products<sup>(1)</sup> in Table 1, an extension of expiry date<sup>(4)</sup>, is appropriate for the specific lots<sup>(2)</sup> indicated. Any product that you have on hand, specific to the indicated lots, should be considered to be acceptable for its intended use through the extended expiry date<sup>(4)</sup>.
