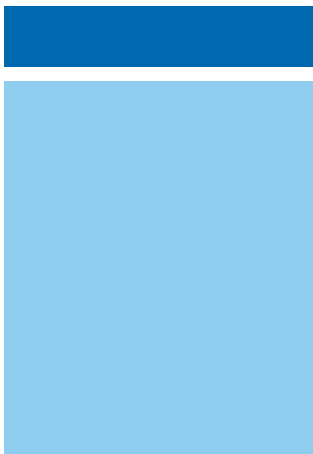
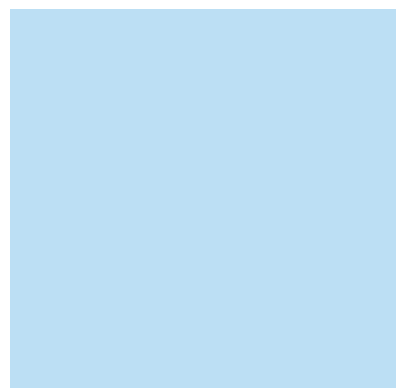

We offer two versions of this non-woven substrate for greatest efficiency. The 100 count flowpack and 200 count canister wetlaid wipes offer the most efficient and economical product. The 30 count flowpack offers a thicker spunlace wipe which is softer for use on the patient's face.

3. Do not rinse, allow to dry

MEDICAL DEVICE DISINFECTING WIPES

BIOCIDE STANDARDS AND REGULATORY APPROVAL

- In regulatory terms, PT1 approval refers to a biocide that is suitable for use on skin and PT2 applies to a biocide that is approved for use on surfaces
- PURELL Hand and Surface Sanitising Wipes are unique in that they are approved for both PT1 and PT2
